CAMPERSHIP INSTRUCTIONS

Mackinac Island Scout Service Troop 127 strives to make the Mackinac Island experience available to all interested Scouts. To that end, we receive donations to assist registered youth members of MISST127 who may not be able to afford all of the costs associated with the program. Campership funds vary from season to season and are not guaranteed. Awards of campership funds is at the discretion of MISST127 leadership and will remain confidential.

ELIGIBILITY

To be eligible for financial assistance a youth must be:

1. Registered and in good standing with the Scout's unit.
2. In need of financial help in order to attend Mackinac Island Scout Service Program.
3. Recommended for aid by the unit leader.

We request your help in making camperships available to the deserving youth members of your unit. Please review the youth in your unit and make recommendations where applicable. Provide the applications for parents to complete the parent information. The unit leader must complete and sign all requests. It is our belief that each applicant should pay some portion of his or her fee and that the unit and chartered partner should also pay a portion of the fee. Normal limits for camperships will be up to one half of the published Scout fee. Special hardship requests require discussion with the MISST Campership Committee. Applications for campership must be made in writing using the MISST127 Request for Campership Form.

CAMPERSHIP NOTIFICATION

Notification of camperships awarded will be given to the Parent/Guardian indicated on the form and applied directly to the Scout's balance.

COMPLETING THE REQUEST FOR CAMBERSHIP

It is important that all questions on the request for campership form be answered completely. Camperships are awarded based on need, and those needs can only be determined from the information on the form. Incomplete forms will be returned to the applicant for completion.

AWARDING CAMBERSHIP

We desire that all camperships be awarded with a minimum of publicity to protect the privacy of the recipient(s). There must be no promise made to applicants that they will receive campership support. Campership awards are limited by the campership funds available.
